# *Kinloch Sheepdogs* Canine Semen Request and Waiver Form

## **Extent of Obligation & Limitation of Liability Waiver**

Your business is greatly appreciated! Kinloch Sheepdogs takes great pride in successfully completing shipments of semen domestically and internationally. In consideration of circumstances beyond our control, we require this liability waiver be read and signed for all of our shipments.

a) Kinloch Sheepdogs makes no representation or warranty that a successful whelping will result from any breeding. We strongly recommend that the Bitch Owner consults a specialist AI vet prior to signing this contract. We further recommend the Bitch Owner uses trained and experienced veterinarians to conduct inseminations with frozen semen to maximize the chances of a successful breeding. Kinloch Sheepdogs shall be held harmless for any errors, failed inseminations, failure of the bitch to conceive or to reach term, disease or injuries to the bitch, or any other mishaps attributable to frozen semen artificial insemination. No refunds are provided for a failed insemination.

b) The Bitch Owner understands that they agree to assume all responsibility for the condition of the bitch and shall bear all risk of loss, damage, or injury to the bitch from any cause whatsoever and therefore agrees to hold Kinloch Sheepdogs and the Stud dog owner, or any person employed by or associated with Kinloch Sheepdogs or the Stud dog owner, harmless for any injury or illness to the bitch associated in any way with breeding with frozen semen provided by Kinloch Sheepdogs.

c) Kinloch Sheepdogs shall not be responsible for loss or accidental thawing of semen which results from storage tank failure, from any act by agents who may be retained to transport semen, or from any acts by agents of Kinloch Sheepdogs unless such acts constitute gross negligence, or from any other cause beyond the reasonable control of Kinloch Sheepdogs.

d) Kinloch Sheepdogs is an International Sheep Dog Society (ISDS) registered agent and represents sire owners in providing frozen semen as a service to bitch owners. Kinloch Sheepdogs makes no warranties or guarantees, either expressed, implied or by any means of interpretation in connection with this agreement.

e) Kinloch Sheepdogs will submit AI Mating forms to the ISDS on behalf of the Bitch and Sire Owners if the bitch owner wishes the pups to be ISDS registered. An Insemination Letter signed by the Veterinarian outlining the name of the bitch, registration number, microchip number and the date of insemination must be provided to Kinloch Sheepdogs within 7 days of the insemination.

f) The Bitch Owner understands that they are not permitted to split straws/pellets and complete more than the number of breedings outlined in this contract.

g) All frozen semen must be paid in full prior to shipping.

h) By signing this agreement, the Bitch Owner understands and accepts the terms of this agreement.
